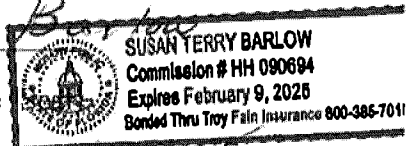

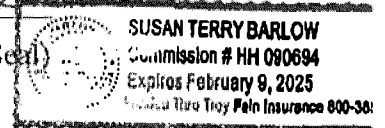

**BYLAWS OF OX BOTTOM MANOR COMMUNITY ASSOCIATION, INC.**

**Article VI**

**Community Powers**

The COMMUNITY shall have all powers granted to it by common law, Florida Statutes, the COMMUNITY Declaration, the Articles of Incorporation of the COMMUNITY and these Bylaws, all of which shall be exercised by its Board unless the exercise thereof is otherwise restricted in the Declaration, these Bylaws or by law. The powers of the COMMUNITY shall include but not be limited to the following:

...

16. The power to levy fines and suspensions for violations of any Declaration governing Lots within Ox Bottom Manor, the Articles, these Bylaws, and any Rules and Regulations promulgated pursuant thereto. No fine shall exceed \$200.00 per violation. However, a fine may be levied on the basis of each day of a continuing violation, with a single notice and opportunity for a hearing as provided by law. The aggregate fine for a continuing violation shall not exceed Five Thousand Dollars (\$5,000.00).
